Our objective is to get younger people impassioned about our sport and to harness the enthusiasm, knowledge and skills of the games' Professionals and its Clubs.

Through our programme of grants, we support Real Tennis clubs to reach out to all young people in their local communities. Teaching young people to play Real Tennis, inspiring a love of the game and its tradition of good sportsmanship.

We also help to create sustainable junior membership sections within clubs and significantly increase the number of under-24s involved in the game and keep them engaged.



We support clubs that show an eagerness to work with young people by increasing youth involvement on an open-access basis. We encourage clubs to devote court time and other resources to young people from their local communities, schools and youth groups.

This has resulted in many UK clubs entering a club junior team to play in the National Inter-Club Handicap Tournament for juniors called the Peter Luck-Hille Cup run by the Foundation. We also run junior coordinator courses to give club amateur players the knowledge and skills to support their Professional in the running of junior coaching sessions.

HOW YOUR GIFT WILL HELP ?

Your gift will protect and nurture the crucial work of The Dedanists' Foundation by:-

- **Awarding Cash Grants** to clubs to fund new programmes, to encourage youngsters to play the game. Clubs that have already received grants are Bristol, Cambridge, Canford, Hatfield, Middlesex, Seacourt, Hampton Court, Oxford, Queen's, Newmarket, Leamington, Moreton Morrell, The Hyde, Jesmond Dene, Oratory, Manchester, Petworth, Prested and Wellington.
- **Helping University Student Real Tennis Clubs.** We have identified these as a very effective means of recruiting new young players and well worth our support. Cash grants have been made to each of the following University Student Clubs:- Bristol, Middlesex, Exeter, Newcastle, Durham and St Andrews. We sponsor the annual Inter-University Tournament at Cambridge Real Tennis Club.
- **Organising Inter-Club Junior Competitions.** The Dedanists' Foundation has created a Junior competition that encourages clubs to recruit more schools and youngsters into the game. This competition is run on a handicap basis, designed predominantly to include youngsters aged 12-15 with handicaps ranging from 50 to 90.

SUGGESTED WORDING FOR YOUR WILL

Should you decide to make a gift to The Dedanists' Foundation you can choose to leave either a share of the residue of your estate or a fixed amount. It is very simple to leave a gift to The Dedanists' Foundation in your will. If you would like to leave a share of the residue of your estate, your legal adviser may find the following wording helpful:

"I/We give all/a share of (please state fraction/percentage) the residue of our/my estate to The Dedanists' Foundation, c/o The Queens' Club, Palliser Road, London W14 9EQ. Registered Charity No. 1145526, to be applied for the general purposes of The Dedanists' Foundation and I/We direct that the receipt from a proper officer for the time being of The Dedanists' Foundation shall be a complete discharge to my/our Executors."

Should you wish to make a gift of a fixed amount, set out below is suggested wording which your legal adviser can use:

"I/We give to The Dedanists' Foundation, c/o The Queens' Club, Palliser Road, London W14 9EQ. Registered Charity Number No.1145526, to be applied for the general purposes of The Dedanists' Foundation, the sum of (amount in figures, amount in words) and I/We direct that the receipt from a proper officer for the time being of The Dedanists' Foundation shall be a complete discharge to my/our Executors."

TAX AND MAKING A CHARITABLE DONATION IN YOUR WILL

Please remember that as The Dedanists' Foundation is a registered Charity (No. 1145526), your legacy gift will be exempt from Inheritance Tax. We recommend that you seek legal advice from your legal advisor. We would further recommend using a member of STEP (Society of Trust and Estate Practitioners) or Solicitors for the Elderly.

Please note under present legislation should you give 10% or more of your residuary estate to a charity, you would pay a reduced rate of Inheritance Tax.

SEEKING PROFESSIONAL ADVICE
